

## WVU Extension Service Terms and Conditions License Agreement – Draft

### Legal Notices

Please read this license agreement carefully before proceeding as this policy governs the terms of your acceptance and use of WVU Extension Service Websites.

By using West Virginia University (“WVU”) Extension Service Websites or transmitting any content, you agree to abide by the terms and conditions set forth herein this license agreement. ### Limited License
